This is in continuation of Environmental Clearance issued by the State Level Environment Impact Assessment Authority (SEIAA), Jharkhand vide letter no.- EC/SEIAA/2018-19/2083/2018/710, Ranchi, Date: 08.11.2019 and further reference to your letter dated – 22.01.2022 and online application no. - SIA/JH/IND/252291/2022 requesting for corrigendum of Environmental Clearance with regard to change of **EC condition no. vi & xv regarding fuel and water requirement.**

2. The State Level Environment Impact Assessment Authority (SEIAA), Jharkhand has accorded the Environmental Clearance vide office letter no.- EC/SEIAA/2018-19/2083/2018/710, Ranchi, Date: 08.11.2019 for “Expansion of Existing Auto Components – 3000 TPA, Engineering Items – 600 TPA, Export Items (Auto Components + Engineering Items) 754000 Nos./yr. to various Forgings 60000 TPA for M/s Ramkrishna Forgings Limited – Plant 1 at Plot No.- M5 & M6 , 6th Phase, Adityapur Industrial Area, Gamhria, Dist. : Saraikela-Kharsawan, Jharkhand”. The project proponent has requested to issue the corrigendum of Environmental Clearance w.r.t. change of **Condition no. vi** which is mentioned as “As proposed, only furnace oil and diesel will be used as fuel to reduce particulate emissions” and **Condition no. xv** which is mentioned as “Total water requirement from ground water source shall not exceed 150 m³ / day”.

3. Your request has been examined by the State Level Environment Impact Assessment Authority (SEIAA), Jharkhand in its 94th meeting held on 13th, 14th & 15th April, 2022. based on the information furnished/provided and discussion held, the State Level Expert Appraisal Committee, (SEAC) and recommended to issue Corrigendum of earlier Environmental Clearance vide its 93rd meeting held on 18th, 19th, 20th, 21st, 22nd, 23rd, 24th, 25th, 26th and 27th February, 2022 is as follows:

The New EC condition no. vi & xv should be read as follows :

Condition no. vi is to be mentioned "Only furnace oil and diesel will be used as fuel to reduce particulate emissions, which was mentioned in salient features of the issued EC".

Condition no. xv is to be mentioned "Total water requirement from ground water source shall not exceed 150 m³ / day which was mentioned in salient features of the issued EC".

4. All other terms & conditions mentioned in the letter no EC/SEIAA/2018-19/2083/2018/710, Ranchi, Date: 08.11.2019 shall remain the same.
