1. Your request has been considered by SEIAA, Jharkhand in its 112th meeting held on 23rd and 24th May, 2024 and following decision was taken therein:-

"Earlier said project was considered and appraised by the Expert Appraisal Committee - 1(Industry) in its 16^{th} meeting held during 22^{nd} to 24^{th} November, 2010. The EAC recommended the proposal for Environment Clearance subject to stipulation of specific conditions along with other Environmental conditions. EAC has also noted that no public hearing / consultations was required because of project being located in notified Patratu Industrial Estate as per see (iii), stage (3), para (i)(b) of EIA Notification, 2006".

Ministry based on the recommendation of EAC granted the Environmental Clearance in favour of "Integrated Cement Plant M/s Burnpur Cement Limited at Patratu Industrial Area, Village – Patratu, District – Ramgarh, Jharkhand" vide F. No. - J-11011/45/2009-IA II (I), dated – 30th December, 2010 on following Khata and Plot No.:

Further, project Authority has submitted online application to SEIAA. Jharkhand vide online application no. – SIA/JH/IND/21810/2009 requesting extension of validity of the Environmental Clearance for 03 (three) years up to 29th December, 2020.

The said project was examined in the 61th meeting of SEAC held on 24th to 26th September, 2018 and SEAC has made recommendation for extension of the validity of Environmental Clearance till 29.12.2020. SEIAA also in its 61st meeting held on 08th and 09th October, 2018 decided to extend the validity of Environmental Clearance till 29.12.2020 and accordingly extension of Environmental Clearance was issued vide SEIAA letter no. – EC/SEIAA/2017-18/2068/2017/261, dated – 05.11.2018.

The said project proposal was again considered in the light of section 11 of Environment Impact Assessment Notification. 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by MoEF & CC vide F. No. – J-11011/45/2009-IA-II(I) dated 30th December, 2010 in the favour of "Integrated Cement Plant (0.528 MTPA) at Patratu Industrial Estate District – Ramgarh in Jharkhand by M/s Burnpur Cement Limited". Accordingly extension of the validity of Environmental Clearance was issued by SEIAA, Jharkhand vide SEIAA letter no. - EC/SEIAA/2017-18/2068/2017/261, dated – 05.11.2018 in the favour of "Integrated Cement Plant M/s Burnpur Cement Limited at Patratu Industrial Area, Village – Patratu, District – Ramgarh, Jharkhand". Further corrigendum was issued by SEIAA, Jharkhand vide letter no. – EC/SEIAA/2017-18/2068/2017/186 dated 30th April, 2019.

The applicant vide online application no SIA/JH/IND1/470705/2024 has requested to transfer of Environmental Clearance in favour of "Integrated Cement Plant of M/s UltraTech Cement Limited, Unit: Patratu Cement Works at Patratu Industrial Area, Patratu, Ramgarh, Jharkhand" for which transferor has submitted no objection certificate affirming that the Environmental Clearance will be transferred in favour of "Integrated Cement Plant of M/s UltraTech Cement Limited, Unit: Patratu Cement Works at Patratu Industrial Area, Patratu, Ramgarh, Jharkhand" and they do not have any objections regarding the transfer of

) Pi Environmental Clearance and all the terms and conditions at Environmental Clearance dated 30th December, 2010 shall be complied by "UltraTech Cement Limited". In accordance with the SARFAESI Action under securitization and Reconstruction of Financial Assessts and Enforcement of Security Interest Act, 2002 read with Security Interest (Enforcement) Rules, 2002, UltraTech Cement Limited ('UltraTech') has taken control over the assets of Burnpur Cement Limited of their Patratu unit on November 29, 2023.

After the full deliberations, it was unanimously decided that Environmental Clearance issued by MoEF & CC vide F.
