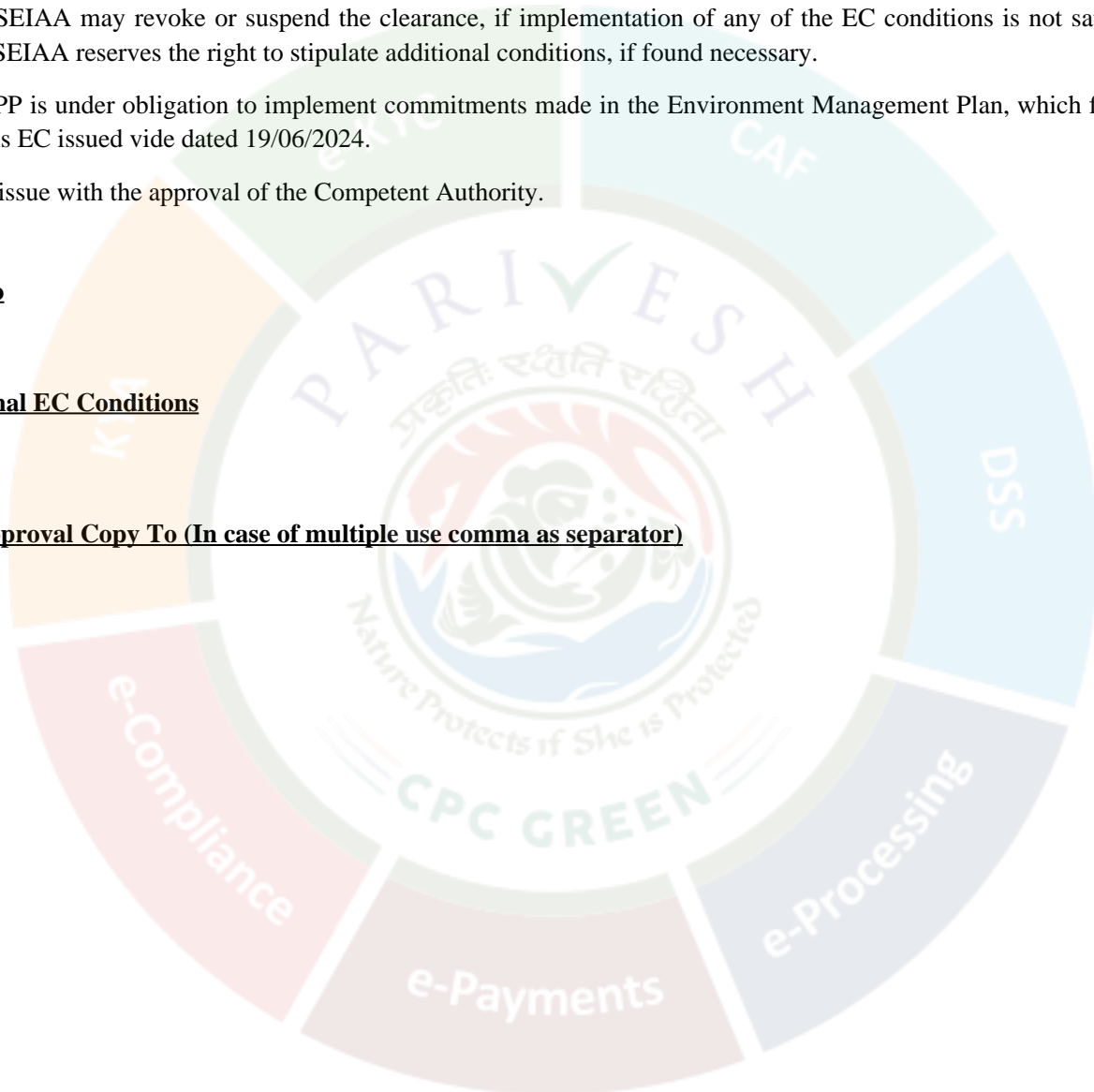

2. It is also noted that Modernization Cum Expansion of Straight Bar & Wire Mill of M/s Tata Steel Long Products Limited has submitted no objection certificate that Modernization Cum Expansion of Straight Bar & Wire Mill of M/s Tata Steel Limited, Gamharia shall abide all the conditions prescribed in the Environmental Clearance letter no. EC/SEIAA/2015-16/872/2015/262, date : 05.11.2018 and Transfer of Environmental Clearance

vide letter no. 97, dated 16.04.2022 issued in the favour of **Modernization Cum Expansion of Straight Bar & Wire Mill of M/s Tata Steel Long Products Limited** and have also agreed for the transfer on the same terms and conditions under which prior Environmental Clearance was granted.

3. The Scheme of Amalgamation of Tata Steel Long Products Limited (CIN: L27102OR1982PLC001091) into and with Tata Steel Limited (CIN: L27100MH1907PLC000260) ('Scheme of Amalgamation'), as approved and sanctioned by the Hon'ble National Company Law Tribunal (Hon'ble NCLT), Cuttack Bench (having jurisdiction over the Company) vide its order dated **10<sup>th</sup> October, 2023** and the Hon'ble NCLT, Mumbai Bench (having jurisdiction over Tata Steel) vide its order dated **20<sup>th</sup> October, 2023**.

4. The proposal was considered by the State Level Environment Impact Assessment Authority, Jharkhand in its **113<sup>th</sup>** meeting held on **07<sup>th</sup> & 08<sup>th</sup> June, 2024** and the Authority has approved the proposal for transfer of Environmental Clearance in the name of "**Modernization Cum Expansion of Straight Bar & Wire Mill of M/s Tata Steel Limited, Gamharia**".

5. The Authority has no objection for transfer of Environmental Clearance accorded by the SEIAA, Jharkhand letter no. : **EC/SEIAA/2015-16/872/2015/262**, date : **05.11.2018** and Transfer of Environmental Clearance vide letter no. 97, dated 16.04.2022 in the name of **Modernization Cum Expansion of Straight Bar & Wire Mill of M/s Tata Steel Limited, Gamharia** from **Modernization Cum Expansion of Straight Bar & Wire Mill of M/s Tata Steel Long Products Limited** with the same terms and conditions under which prior Environmental Clearance was granted for the same validity period subject to satisfactory compliance of all the stipulated specific and other conditions.
